Assembly Steps




This Loveseat has multiple parts and may require about 30 minutes to assemble. To give you an overview of the Loveseat parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

Step 1




Take out the Backrest(B) from the Carton "A", place them on a clean, non-marring surface.

Step 2




Take the Sofa Base(A), Left Arm (C), Right Arm(D) and bag out from the carton "B" and place them on a clean, non-marring surface.



Open the Bag to take out the Wooden Legs(E) and Hardwares.


Step 4




With assistance from your adult partner, hold up the Sofa Backrest(B), while standing behind the Left Arm(C) and Right Arm(D).

Align the mounting brackets on both sides of the Sofa Backrest(B) with those on the Left Arm (C) and Right Arm (D).

Then slide Sofa Backrest(B) downward by hand to make sure it locks into place as pictured.




With assistance from your adult partner, put the Sofa Base between the Left Arm(C) and Right Arm(D) under the Sofa Backrest(B) as a whole as picture, Align the bolts holes on the both side of Sofa Base(A) with those on the Left Arm(C), Right Arm(D).



With assistance from your adult partner, place the whole product on a clean, non-marring surface. then attach using Bolts((2)), Spring Washers((4)) and Washer((3)) with Allen Key((7)).

Pls don't tight the bolts and just to be bolted half-way at the moment(until to Step 7).




Open the back non-woven cover under Sofa Base(A).

You will see two mounting positions on the hind-top panel of the Sofa Base(A). Insert Double-threaded Bolts(⑤) into mounting positions and turn it clockwise by hand until 1/3 inside(make sure keep the Double-threaded Bolt out 2-3cm).

Then, place Washer Rings(3) and Spring Washers(4) onto the Double-threaded Bolts(5), and secure using Wing Nut(6).

Note:First screw the Double-threaded Bolts(⑤) into place, then screw the Wing Nut(⑥).

Tighten Wing Nuts fully by turning them clockwise by hand in a sequential manner.




Install the Wood Legs(E) at the bottom of the Sofa by placing one Gasket(①) on the threaded stem.

Tighten by turning the Leg clockwise.


Note: The use of Gaskets are OPTIONALand are especially useful to help alleviate slight wobbleness. Some Legs may need more than one Gasket whilst some Legs may not need any.

Step 9



Make sure all of the parts connected to the right position and stronge enough. Now your Sofa is ready for use.

This Sofa can only be used on a flat, level surface.



Questions & Answers about Proposition 65

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
